General Information: F-20 ENVIRO CLEAR when properly applied, will effectively coagulate and flocculate a wide variety of suspended solids.

Using F-20 ENVIRO CLEAR with Fish: Certain species of fish may be killed at application rates recommended on this label due to gill plugging. If the water to be treated is extremely turbid, extend the application time to reduce the chance of larger particles plugging the gills. Allow sufficient time for the fish to move into untreated areas.

How to Estimate Lake or Pond Size:
Measure Length (L), Width (W) and average Depth (D) in FEET. Then multiply for:

Square shaped bodies of water:
 $L \times W \times D \times 7.5$ = approximate gallons

Circular or Elliptical bodies of water:
 $L \times W \times D \times 5.9$ = approximate gallons

Total gallons divided by 325,851.6 (gallons per acre feet)
= Acre Feet

Directions: F-20 ENVIRO CLEAR must be slowly dripped into rapid moving, turbulent water or may be injected directly into the pump intake using a chemical metering pump. See below for recommended dosage. Do not add more than 10 ppm in one single application.
